In the Name of God Amen. I John Huchins of the parish of Lighthorne in the diocese of Worcester, sick in body but of perfect memory and good mind Thanks be to God, do ordain & make the 7th day of May A.D. 1587, this my Last Will and Testament in manner and form following. First I commend my soul into the hands of Almighty God and my body to be buried in the church yard of Lighthorne in sure hope of the Resurrection of the same to life everlasting in the last day.

Item I give to Catherin my daughter a mattress my best & third coverlet a good blanket two pairs of sheets a bolster two boardclothes 1 towel my best pot 4 platters my best & third coffers.

Item I give to Joan my daughter my lesser pot 2 platters and 2 ---a coffer 2 pairs of peterson coverlet. My will is that my very friend Edmond Horhern of Pinock shall seisin into his hands Catherins bequest and from half of the price of my red cow to buy for her a young beast the third day of May the next year, to keep all safe till the day of her marrying & to take his counsel to marry with an honest man. If she marry not within these four years to receive the which parcel into her own use, but so to use it well for her help & comfort or else to remain to my --- and youngest daughter Joan.

Item I give to Margaret my wife, & after her decease to Joan my daughter the lease of my house. The fine was agreed upon £4, of which sum is paid as appeareth after the rest my wife shall pay at the sealing of the lease.

The rest of my goods movable & unmovable I give to Margaret my wife (performing these my bequests, paying my debts & discharging my funeral) whom I make mine executrix of this my Last Will and Testament to do therein as God shall give her grace according to the true meaning thereof.
